The Federation of Indian Export Organisations, popularly known as FIEO is the apex body of all export promotion organizations in Indian. Ever since set up by the Ministry of Commerce, Government of India, in 1965, FIEO has also been serving as a platform for promoting Indian trade with the World and also has been serving as a platform of interaction between exporters and policy makers. Thus, FIEO represents the Indian export promotion effort in its entirety.

FIEO has offices located at various places all over India including Head office at New Delhi while other offices at Kolkata, Mumbai, Chennai, Bhubaneshwar, Bangalore, Hyderabad, Kanpur, Shilong and Ahmedabad. FIEO has a membership base of nearly 13,000 members from all over the country, representing a wide cross section of products and services. By streamlining its various processes, FIEO has achieved the status ISO 9001:2000 certified organization which speaks of its objective to provide quality service to all its associates.

Illustrating vision and dedication, FIEO today has its own state of art office complex 'Niryat Bhawan' located in New Delhi.
